Grant of Environmental Clearance to develop township hill station in Taluka - Mulshi, Velhe, District - Pune.

Sir,

This has reference to your letter dated 09/01/2004 regarding Environmental Clearance for the Lake Town hill station in Mulshi and Velhe Tehsil, District - Pune. The Environmental Impact Assessment Report (EIA) submitted by you was examined. The environmental clearance to this project is hereby granted subject to following conditions:

- 1. The hill station project area shall be 2,000 hectors (Two Thousand Hectores) as permitted by Urban Development Department vide Govt.Resolution No.TPS-1896-1231-CR.123-96-UD-13 dated 26.11.1996.
- 2. Forest admeasuring 2237 hectores comprising Government Forest, Proposed Forest and the Forest proposed by the Company shall be protected from the habitations and the development activities of the hill station so that effects of the project on the Flora and Fauna of the surrounding area shall be minimised. For this purpose a safe distance as a buffer between forests and project area as indicated in the land use pian shall be provided.

- transit losses etc. shall be accounted while planning for water resources. Harvesting of eight Bandharas at Mose River basin and two Bhandhara's of WFR basins as proposed in the report to the extent of 2634 million litres / year will be necessary. It shall be ensured that the demand of water by other users in these basins shall not conflict.
- 4. The separate underground drainage arragement, sewage treatment plant and disposal of treated effluent shall be provided as per MPCB prescribed norms. The overflow and seepage of gardening water shall be collected and reused for gardening. The waste water disposal system shall be designed in such a manner that no waste water directly or indirectly enter into surrounding water resources.
- 5. The external approach road namely Mumbai Lonavala Pune Chandani Chowk Dasve, Mumbai Lonavala-Tamhini-Lake Town-Mugaon, Kolad Lonavala-Lake Town-Mugaon, Pune Chandani Chowk-Lake Town-Dasve are estimated to be adequate for 6,000 vehicles per day. However, in case of increase traffic density the upgradation of these roads shall be eminent.
- 6. Emissions from eating houses, helipad, vehicles etc. shall be controlled in such a manner that the ambient air quality in the trea shall not exceed prescribed limit for the residential area. The Noise Pollution Level shall not exceed the prescribed limits.
- 7. Municipal Solid Waste shall be segregated, minimised, recycled and organic waste shall be treated as per modern methods such as vermi-composting, biomethanation etc., As far as possible use of plastic bags, thermocol etc, shall be prohibited in the hill station area by declaring as 'No Plastic Zone'
- 8. Bio Medical waste shall be segregated, collected, transported and treated in the authorised facility.
- 9. The above permission is without prejudice to any other permissions required under any of the laws, bye-laws or regulation in force and that the Government may impose any additional condition from time to time for environmental protection, if necessary.

- 10. The project authority shall set up environment management cell with suitably qualified staff, to carry out various functions of the environment management. The funds for management of Environmental Management Cell shall be seperately earmarked.
 - 11. This environmental clearence is not transferable and shall lapse after a period of two year from the date on which the clearence is given, unless the intended development is commenced.
