Namami Gange (NMCG), however, it is clarified that no fresh financial proposal need to be submitted as the work is being executed under the tenders invited already. The liability of Namami Gange shall be limited at the first instance to the 7 STPs project that they have approved. In relation to remaining 7 Projects of STPs, the Delhi Jal Board shall commence its work without any further delay from its own budget. Delhi Jal Board shall give its proposed Action Plan in furtherance to the above order to I.I.T. as well as Namami Gange. Comments thereof should be submitted before the Tribunal before the next date of hearing.
