UPON hearing counsel the Court made the following

ORDER

Mr. Prashant Bhushan, learned counsel for the petitioner has drawn our attention to Section 13(1) of the Food Safety and Standards Act, 2006 (for short 'the Act'), in terms of which the Government has to constitute a scientific Panel consisting of independent scientific experts and that scientific Panel in turn shall invite relevant industry and consumer representatives in its deliberation but the panel must consist of only independent scientific experts according to Section 13(1) of the Act.

to Mr. Bhushan, some members of the Panel appointed by the According respondents are not independent scientific experts and their appointment is not in consonance with Section 13(1) of the Act. At this stage, learned counsel appearing for submits the Food Safety and Standards Authority that the Penal would be reconstituted in terms of Section 13(1) of the Act, within two weeks from today and an affidavit would be submitted before this Court.

Mr. Bhushan undertakes to file a comprehensive representation and suggestions before the said Panel and the Panel would consider the same. If a request for personal hearing is made by Mr. Bhushan, the same would also be considered by the said Panel in accordance with law.
